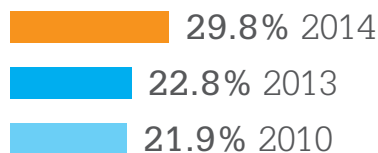
Increasing the number of students who graduate from high school ready for college and career is a unifying priority for educators from every state. The College Board believes that its programs can be a platform to expand access to opportunities — through scholarships, challenging course work, fee waivers, and much more — and to propel students into college and career. Our programs — PSAT/NMSQT®, SAT®, and AP® — work together to provide actionable results, drive instructional next steps for individual students, and provide targeted policies for states and districts. Below is a summary of the 2014-15 PSAT/NMSQT, SAT, and AP participation and performance results in Oklahoma.¹

ALL SCHOOLS' PARTICIPATION RESULTS

PSAT/NMSQT®

In 2014, 23,710 students benefited from taking the PSAT/NMSQT, compared to 20,298 in 2013 and 17,893 in 2010.

→ **29.8%** were underrepresented minority students, compared to 22.8% in 2013 and 21.9% in 2010.



→ Last October, **21.8%** of 10th-graders and **21.8%** of 11th-graders took the PSAT/NMSQT.²

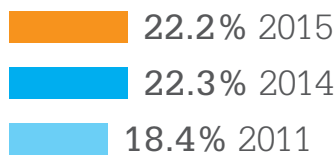

SAT[®]

In Oklahoma, 1,720 or 4.4% of students from the class of 2015 took the SAT, compared to 1,725 students (4.5%) in last year's graduating class and 2,110 (5.3%) in the class of 2011.³

→ **22.2%** were underrepresented minority students, compared to 22.3% in 2014 and 18.4% in 2011.

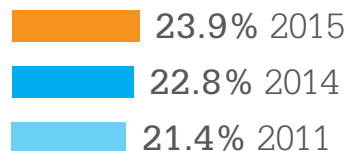


→ **9.0%** took the test using a fee waiver, compared to 8.5% in 2014 and 7.2% of the class of 2011.

AP[®]

In Oklahoma, 17,336 students took an AP Exam in 2015, compared to 16,453 in 2014 and 15,120 in 2011.

→ **23.9%** were underrepresented minority students, compared to 22.8% in 2014 and 21.4% in 2011.



→ **22.8%** were low-income students, compared to 22.5% in 2014 and 22.3% in 2011.

In Oklahoma, students took 30,011 AP Exams in 2015, compared to 28,345 in 2014 and 25,188 in 2011.

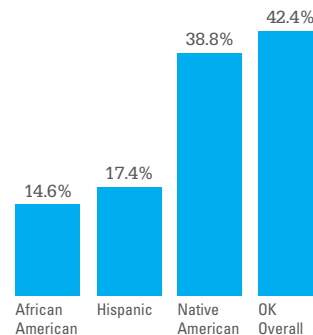

ALL SCHOOLS' PERFORMANCE RESULTS

PSAT/NMSQT®

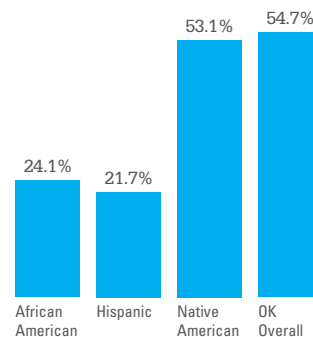
In Oklahoma, 4,556 (42.4%) 10th-grade PSAT/NMSQT® takers in 2014 were on track for college readiness.

- **14.6%** of 10th-grade African American PSAT/NMSQT takers met the benchmark.
- **17.4%** of 10th-grade Hispanic PSAT/NMSQT takers met the benchmark.
- **38.8%** of 10th-grade Native American PSAT/NMSQT takers met the benchmark.



In Oklahoma, 5,371 (54.7%) 11th-grade PSAT/NMSQT® takers in 2014 were on track for college readiness.

- **24.1%** of 11th-grade African American PSAT/NMSQT takers met the benchmark.
- **21.7%** of 11th-grade Hispanic PSAT/NMSQT takers met the benchmark.
- **53.1%** of 11th-grade Native American PSAT/NMSQT takers met the benchmark.



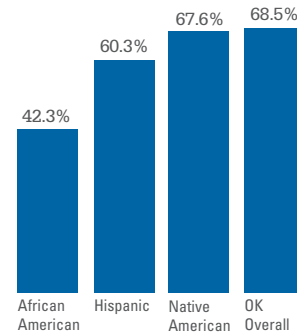
In Oklahoma, 3,346 10th-grade PSAT/NMSQT takers in 2014 demonstrated potential to succeed in at least one AP course, including 1,437 in an AP STEM subject.

In Oklahoma, 456 underrepresented minority 10th-grade PSAT/NMSQT takers showed potential for AP success, including 155 in an AP STEM subject.

SAT

In Oklahoma, 1,178 (68.5%) SAT takers in the class of 2015 met the SAT College and Career Readiness Benchmark.

- **42.3%** of African American SAT takers met the benchmark.
- **60.3%** of Hispanic SAT takers met the benchmark.
- **67.6%** of Native American SAT takers met the benchmark.



AP

In Oklahoma, 8,655 students scored 3 or higher on an AP[®] Exam in 2015, compared to 8,352 in 2014 and 7,611 in 2011.

- **49.9%** of AP Exam takers scored 3 or higher on at least one AP Exam in May 2015.
- **29.6%** of African American AP Exam takers scored 3 or higher on at least one AP Exam.
- **42.3%** of Hispanic AP Exam takers scored 3 or higher on at least one AP Exam.
- **46.4%** of Native American AP Exam takers scored 3 or higher on at least one AP Exam.
