

SKILLS ASSESSED

Based on a nationwide survey of college composition curricula, the exams are designed to measure the following skills:

- → Conventions of Standard Written English, including students' awareness of a variety of logical, structural, and grammatical relationships within sentences; recognition of acceptable usage
- → Revision skills, including students' ability to draft, develop, and organize essays; awareness of audience, tone and purpose; sentence variety and structure
- → **Ability to use source materials,** including students' familiarity with reference and research skills; evaluation, integration, and documentation of source materials
- → **Rhetorical analysis,** including students' ability to critically analyze texts for rhetorical elements pertaining to style, purpose, situation, and effect
