Due to time frames of producing our program brochure, information on sessions, presenters and events may have changed. Changes will be posted for your review.



In order to produce graduates who are college and career ready, today's high schools must prepare students to succeed in any postsecondary experience. In this session, K–12 educators will learn how to build and foster key components of college readiness: clear communication, high expectations for all students, rigorous curricula, student support and stakeholder engagement. Participants will examine and assess strategies that exemplary schools have utilized to achieve student success after high school. They will evaluate their own practices and develop a set of new strategies that they can implement immediately at their schools.

Community Reads: Building a Collegiate Reading Program **CEU**

To engage students in the social and intellectual enjoyment of collegiate reading, Osborne High School has begun a community reading program. The books, which are selections from college freshman summer reading lists, span diverse content areas. Students in grades 9–12, faculty from all departments, staff throughout the school, alumni, parents and community members (including university professors and teaching interns) participate together in book discussions led by the senior AP® English classes. The discussions are organized to maximize the contributions of all involved. In this session, participants will build an outline for their own potential community reads program — complete with possible texts, timelines and supporting staff. Participants will evaluate elements such as school diversity, community interests, financial support and internal leadership, while brainstorming methods for program expansion.

Guidance and Admission Assembly

The Guidance and Admission Assembly (GAA) provides a forum for members to discuss issues and actions related to supplying educational opportunities for all students at crucial transition points in their lives. The assembly identifies and responds to the needs of its members as they work, individually and collectively, to encourage students and families to keep their options open and to offer opportunities for student access and success. It presents opportunities for members to engage in dialogue and make their recommendations known to the GAA Council, to the Board of Trustees and to the members of the College Board. The assembly addresses issues related to professional ethics and educational standards, and provides advice on College Board programs and services related to such functions as early awareness, precollege planning, assessment, admission and retention.

Information and Misinformation: Using the NPC to Evaluate Financial Aid Offers CEU

How useful is the Net Price Calculator (NPC) when it comes to college and financial aid planning? Why do financial aid packages differ from seemingly comparable colleges? How can families understand and evaluate the offers they receive? In this session, participants will learn how to translate and evaluate financial aid offers. They will develop tools and strategies for teaching families how to navigate this complex process.

Professional Practice in Enrollment Management CEU

What does it mean to be a professional in enrollment management? What are the foundations upon which the profession rests? This session invites new and seasoned staff members from all areas of secondary and postsecondary education (including admission, financial aid, faculty and enrollment) to learn, participate and lend their perspectives on what it means to be a professional practitioner involved in enrolling and supporting students. Participants will identify the elements that define professional practice in general and enrollment practice in particular. They will apply these elements to the issues, challenges and trade-offs encountered in daily practice.

Using Tuition Cooperatives to Develop Financial Incentives for STEM Majors CEU

The Academic Common Market and other tuition cooperatives allow students to cross state lines but still pay in-state tuition rates. In-state tuition can serve as a powerful financial incentive to attract or retain students. Tuition discount agreements can expand opportunities for STEM majors and increase competition among institutions to recruit these students. In this session, staff from the Tennessee Higher Education Commission will share knowledge and best practices gained from the state's successful Race to the Top STEM Professional Development Grant projects. Participants will assess the impact of current tuition discount policies and identify how such policies affect student choice. Participants will propose collaborative strategies that states can use to develop financial incentives for STEM majors.

The Academic Assembly offers a forum for members to discuss issues and actions related to providing educational opportunities for all students. The assembly promotes educational excellence and equity through the articulation and elaboration of academic standards as well as standards for the delivery of curriculum and instruction horizontally across the disciplines and vertically across the education continuum (K–16). It is a setting in which to address topics on curriculum, articulation, assessment, school governance structures and sustained professional development. This year, the discussion will specifically focus on the skills needed in college classrooms and how secondary and higher education faculty can work together to be sure students are prepared without the need for developmental or remedial course work in college.

ACCUPLACER®: A Measure of College Readiness CEU

This session discusses the design and use of ACCUPLACER® as a measure of college readiness. Participants will assess the use of diagnostic testing and multiple measures for student placement. They will develop tools and strategies to diagnose students' strengths and weaknesses, in order to provide targeted preenrollment interventions.

College Ready: Closing the Achievement Gap and Empowering Latino Students CEU

The Hillsborough County Public Schools district has established academic programs within its secondary schools that have made the concept of college readiness a reality. Two principals of HCPS high schools with large Latino and migrant student populations will join the general director of advanced academic access to discuss the successes and challenges their efforts have encountered. In this session, participants will evaluate the district's attempts to increase graduation rates and AP participation among Latino students, while identifying the challenges facing their own Latino student populations. Participants will develop appropriate interventions and draft a list of best practices for engaging Latino students and their families in college readiness programs.

Ensuring Academic Success Among African American Males **CEU**

Research conducted by North Carolina Central University (NCCU) shows that African American males currently comprise 9 percent of full-time college students in North Carolina. However, data projections estimate that by the year 2017, African American males will represent less than 3 percent of the state's college population (Office of Research, Evaluation and Planning, NCCU). Clearly, much work remains to be done to ensure the academic success for an underserved population of African American males. In this session, participants will brainstorm ways in which the offices of student affairs, academic affairs and alumni affairs can collaborate to identify and address the needs of a diverse student population. Participants will learn techniques to reinvent old, successful student practices to promote self-efficacy, unity, retention and matriculation among African American males.

International Recruiting at Southern Universities: New Approaches CEU

Changes in the global economy have increased the pool of students studying outside their home countries. While East Asia has contributed significantly to the growing numbers of international students at Southern universities, opportunities to attract talented students extend far beyond the Pacific Rim. This session will address major trends that impact international student mobility and recruitment to U.S. universities, particularly those in the southern region of the U.S. Participants will interact with seasoned international admission professionals in order to examine the latest data, discuss the challenges facing international students, and share best practices for recruiting, admitting and enrolling foreign students. They will develop insights and effective approaches for reaching ambitious, diverse populations of students.

Pell Grants: Meeting the Needs of the Melting Pot

The economic recession has changed the mix of Pell Grant recipients. The Pell program is no longer a program solely for students from low-income families; it now supports students from middle-income and many previously high-income families. In this session, participants will evaluate the shift in demographics among current Pell Grant recipients. They will examine detailed information provided by institutions about their Pell recipients and will assess how this information relates to early awareness and outreach activities.

In addition, participants will assess their current programs and services in order to begin the process of developing a datadriven school counseling program.

Building a STEM Mind-Set in Pre-AP® Science and Mathematics Classrooms CEU

Inquiry-based labs and problem-based learning are just two of the strategies teachers can investigate as they work to develop a STEM Mind-Set that directly connects science and mathematics concepts and activities in the classroom. This session will highlight the structure and key activities of a two-day workshop model that involves back-mapping from AP science and mathematics courses to Pre-AP® courses, investigating direct connections between select concepts, and identifying Pre-AP and AP strategies that will support student readiness. Participants will practice a handful of select Pre-AP and AP strategies that emphasize the natural connections between science and mathematics. They will develop a set of best practices for building a STEM Mind-Set among their students.

Participants will brainstorm ways in which current students can maximize recruitment efforts ranging from the "campus visit" to social media and beyond. They will assess commonly used recruitment tactics and resources, comparing the impact and the admission yield to that of student-based recruitment strategies.

Join us for Edward L. Ayers's engaging presentation, "The Civil War and Emancipation 150 Years On." Ayers is leading a national conversation about the Sesquicentennial of this significant event, including asking President Obama to consider the freedom of four million Americans as a momentous milestone in American history.

A teacher and scholar of American history, Edward L. Ayers was named president of the University of Richmond in 2007. Since that time, he has led the University of Richmond community in the development of The Richmond Promise—a five-point strategic plan aimed at making the university accessible to a diverse body of students, faculty and staff who work together with the local community to create a distinctive and integrated learning experience for all.

Ayers has also authored *The Promise of the New South: Life After Reconstruction* (1992), a finalist for both the National Book Award and the Pulitzer Prize. It was named the best book on the history of American race relations and on the history of the American South. Ayers is also a co-host of *BackStory*, a nationally syndicated radio show that ties history to the present



Advancing Student Learning and Teaching with AP® Insight CEU

AP Insight is an "always-on" classroom tool, providing insight into diverse student needs and increasing the opportunity for all students to succeed. AP Insight is built around the critical and foundational challenge areas of the AP Biology course and includes time-saving tools for teachers that are grounded in proven learning strategies. In this session, educators from Hillsborough County (Tampa, FL) and the AP Insight team will share their collaborative experience developing and refining AP Insight to address the needs of diverse students in AP classrooms. Participants will utilize the components of the new program — including classroom-ready resources, professional learning tools, and interim assessments with instructionally relevant feedback. Participants will analyze the attributes of formative assessment processes in order to identify effective practices that they can incorporate into their own instructional toolbox.

FAFSA Simplification: The Winners, the Losers, the Alternatives CEU

To reduce the complexity of the federal student aid system and, hopefully, to increase college participation and success, the Obama administration has proposed simplifying the FAFSA by removing the majority of income questions and asset information. The College Board has partnered with five states to model the impact of the proposed changes. The collaboration has considered what the changes will mean for the equitable and efficient distribution of need-based grant funding, who will be helped or hurt by the reduction in eligibility data, and what can be done to minimize any negative consequences. Participants will examine the results of the study and identify its national, state and institutional policy implications. They will develop strategies to preserve equity in the awarding of need-based grants.

Tulane University emerged from Hurricane Katrina with a renewed interest in the well-being of its neighbors. Tulane created the Cowen Institute to conduct research, advocate policy and engage the community in college readiness. One of the institute's signature programs, AdvanceNOLA, implements AP courses in Title I high schools — providing course materials and teacher training. Additionally, AdvanceNOLA has helped to create college-going cultures within schools. In this session, participants will evaluate how universities can develop and lead multisector approaches that connect high-needs schools to needed assets. Participants will develop strategies to leverage university resources, such as access to instructional facilities and postsecondary students; to better support teachers and students in AP courses; and to inspire high expectations for academic success.

The University of Richmond has taken this challenge head-on, integrating a university-wide content strategy with enrollment management processes. In this session, participants will assess the importance of single-source content in marketing to prospective students. Participants will learn how to create university-wide Web content that enhances the college search experience and boosts recruitment.

The school trains parents to play an active role in guiding their children through the application process. 

Fisher v. University of Texas: The U.S. Supreme Court Again Takes On College Admission

The Supreme Court has agreed to hear a case that revisits the question of the appropriate use of race and ethnicity in college admission as a means to achieve institutional diversity goals that are beneficial to students. In *Fisher v. University of Texas*, the Court will review its decision rendered in the 2003 landmark *Grutter* case, where they affirmed the University of Michigan Law School's limited use of race and ethnicity to meet diversity goals. The outcome of this case could reverse or significantly modify that decision. The session will review the current law, the status of the case, and offer suggestions for responses and reactions to possible outcomes. Oral arguments are scheduled for Oct. 10, 2012, and could provide insight into the direction the Court is going with the case. This critical case will have long-standing impact on national goals related to access and success in higher education for underserved populations of college-bound students.

An Innovative Curriculum Designed to Teach Students How to Succeed

Recent data published in the *Chronicle of Higher Education Almanac* (2011) established that only 25 percent of students graduating from American high schools are adequately prepared for college in all academic areas. This statistic demonstrates the increased need to provide additional support for a growing number of students. At many institutions, there are simply not enough resources available for individual outreach and mentoring. As a response to this need, the Office of Academic Support Services at Stevenson University created a course to provide additional support to students who are identified as at risk for academic failure. In addition to individualized goal setting and monitoring, the course covers seven modules that were purposefully selected based on examination of common difficulties experienced by students at Stevenson as well as national trends in academic support. Attendees will leave this session with the outline of a curriculum for potential use at their own institutions.

Bridgeport High School qualified as one of the top three finalists in President Obama's Presidential Commencement Challenge during the spring of 2011. Bridgeport provides a successful model for increasing academic expectations and rigor in a high-poverty, Hispanic student body. The school's AP program is open enrollment, and students take college courses in high school after passing local community college entrance exams. In this session, participants will brainstorm ways to cultivate an atmosphere in which college attendance is expected and accessible to all students, regardless of socioeconomic or racial barriers. Participants will also develop practical strategies to help create college-going cultures within their own communities.

Net Price Calculators: Are They Working?

The mandate for colleges and universities to provide net price calculators has now been in place for about a year. Many in higher education embraced NPCs as a significant step in helping families understand the true cost of college and their aid eligibility. Others were worried about misleading families and losing potential students. How have things turned out? Are NPCs as bad as some predicted or a boon for college-going students? With practitioners as panelists, this session will feature a conversation about best practices and lessons learned in the use of NPCs — exploring their role as an access tool, a relationship-building tool, a financial literacy tool, and as a mechanism for helping families understand affordability and available options.

Predictive Analytics: Using Targeted Interventions to Enhance Persistence

Predictive analytics can be used to provide early, targeted interventions to enhance persistence, academic performance and degree attainment — particularly among students who are most at risk. Since 2006, the University of South Florida has implemented a logistic regression model that predicts the risk of individual student attrition based upon prematriculation characteristics, including the College Student Expectations Questionnaire and various elements of institutional data. Eastern Connecticut State University has also developed a logistic regression model for identifying at-risk students prior to matriculation by combining preenrollment risk factors for attrition and poor academic performance. In this session, participants will compare and contrast the characteristics and effectiveness of both models. Participants will also assess the potential for integrating predictive analytics as the foundation for a campuswide approach to student success at their respective institutions.

Streamlining the Path to Degree Completion Through Effective PLA Policies

Participants will also discuss the impetus for change, including the need to relieve intense enrollment capacity pressures, the push to enhance productivity in the face of rapid disinvestment in public higher education, the recognition of new forms of student learning via open-source providers, and the critical role of adult and veteran student markets in achieving desired degree-attainment goals.

Participants will gain useful insights to help in the development of institutional strategies to prepare for and manage federal and other similar program reviews, as well as to effectively follow up after the review process concludes.

Participants will evaluate the feasibility and value of replicating the model in other states.
