

Duly designated delegates to an assembly of the College Board are entitled to vote in meetings of that assembly and in the Annual Business Meeting of the members of the College Board. If you are a delegate, your voting card will be distributed to you in your registration packet at the regional forum.

Your chief executive officer may designate a person as the alternate delegate to the assembly. To be valid, the Alternate Delegate Designation Form must be signed by the chief executive officer. If you are the official delegate to one assembly, and the official delegate to another assembly is not attending, you may be designated the alternate to a second assembly as well. Please note that even if you are designated the alternate delegate to another assembly, you may cast only one vote at the Annual Meeting of the Members.



#### Why Should Higher Education Leaders Care About State Standards? Key K-12 Partnerships

#### **Location: Ballroom IV**

Higher education faculty in Kentucky have taken a lead role in creating K-12 partnerships and implementing the Common Core State Standards. The result is the collaborative development of high school senior year transitional courses and programs. These courses and programs prepared 24 percent of the students' across Kentucky who were deemed college ready and in two short years accounted for a 13 percent increase in Kentucky students' college and career readiness. The key to this work was creating a postsecondary education understanding of the Common Core State Standards. The focus of this session will be on the impact of those standards on entering higher ed students and college faculty, the impact of the standards on the principles of teaching and learning on college campuses and the impact of the standards on student collegiate success leading to on-time college graduation. Evidence and evidence-based practices will be presented about real changes that have occurred because of postsecondary involvement in the Common Core State Standards movement.

A professional speaker, in 1992 he founded the Channel ZerO Group LLC (CZG), an educational and motivational consulting company. Through his national and international travels and online mentoring presence, Mackie reaches millions of youths and professionals annually.

In 2005, former Louisiana Governor Kathleen Blanco appointed him to the Louisiana Recovery Authority (LRA), the guiding agency to lead the state's rebuilding efforts following Hurricanes Katrina and Rita. In 2009, then Louisiana Lt. Gov. Mitch Landrieu appointed Mackie to the Louisiana Council on the Social Status of Black Boys and Black Men, and he is leading the state's effort to create policy and programs to positively impact the quality of life of black males and families in the state of Louisiana.

He is the author of the best-selling books: A View from the Roof: Lessons for Life and Business and Grandma's Hands: Cherished Moments of Faith and Wisdom, which recently received a silver medal in the prestigious Living Now Book Awards.




