

BIG FUTURE: STUDENT SEARCH TERMS

1. You are opting in to participate in the College Board's Student Search Service® ("Student Search"). "You" or "you" means a student.
2. You understand by opting in that participating, eligible organizations ("Colleges") can then search for groups of students who may be a good fit for their communities and programs, but only among those students who opt to participate in Student Search.
3. You understand that the search criteria can include any attribute you provide on the Student Data Questionnaire (if you completed one while taking the PSAT 8/9, PSAT 10, PSAT/NMSQT®, SAT® or an AP® exams), except the following: disability, self-reported parental income, social security number, phone numbers and actual test scores. The most searched items are expected high school graduation date, cumulative GPA and intended college major. Colleges can ask for names of students within certain score ranges, but your exact score is not reported.
4. You understand that if you opt in and create a college list on Big Future, a College may learn whether you have saved that particular College on your Big Future college list.
5. You understand that by opting in, you'll start getting information that can help you find a college that's a good fit for you. You may get emails, postal mail or both. All of this information helps you get a better picture, so you can find colleges that you may want to attend. Some of the colleges may be familiar – or they might be new opportunities. It's important to know that all of the colleges that you hear from are interested in students just like you. The colleges and organizations that participate want to find students who fit in with their environment, classes, programs, scholarships and special activities.
6. All of the Colleges that use Student Search Service are:
 - Accredited colleges and universities – private universities, state and community colleges
 - Nonprofit educational organizations – scholarship organizations, programs that offer transferable college credits or groups that partner with accredited colleges or universities

Also, the Colleges must agree to our strict usage policies. They will never contact you with commercial advertising.

7. You understand that by being contacted by a College doesn't mean you have been admitted. You must submit an application to be considered for admission. The College Board has no responsibility or liability to you in connection with any information you receive from Colleges or with your application to any College should you choose to apply.
8. To preserve the integrity of the information contained in the Student Search database, the College Board reserves the right to bar or to remove, with or without notice, any student from the database.

Please note that any Colleges that have already received your name and other data may continue to send you information, but your information will not be included going forward from the time you elect to opt out.
