Instructions to the School

Consent must be obtained when a request for the English Learner Time and One-Half (50%) Support; Math Only Text-to-Speech; and Math-Only Testing is submitted electronically (via SSD Online) through school documentation consistent with district policy, or this consent form may be used as an alternate method to obtain consent. Consent shall be retained by the school. This form or alternative evidence of consent does not need to be submitted to the College Board. When submitting the request for supports, the school's SSD coordinator will be asked to verify that a signed consent form is on file at the school and certify that the selected English learner supports are only being requested for those students who, at the time of testing:

- Use the same supports on schoolwork and other assessments, including state assessments.
- Meet the definition of "English learner" as defined by the state where their enrolled school is located, or absent a state definition, federal policy as defined in ESSA.
- Are enrolled in an elementary or secondary school located in the U.S. or U.S. territories.
- Will only use the selected English learner supports for the specified tests.

Required Student Data for Requests

College Board requires the following demographic data for all selected English Learner supports requests submitted in SSD Online:

Name, date of birth, expected high school graduation date, gender, current school, and student email address (optional).
